JOB RESPONSIBILITIES

- Actively observe and provide feedback around the crew's work to eliminate at-risk behavior, identify safety issues and help ensure corrective actions are taken
- Perform injury management including minor first aid, incident root cause investigation and reporting, return to work as needed
- Conduct daily inspections of job sites actively observing and providing feedback around the crew's work, tools, and equipment to eliminate hazards and identify at-risk behavior; advise on and help ensure corrective actions are taken
- Take an active role in the planning of upcoming work on the site to help the team identify potential safety issues and solutions
- Assist with developing, conducting, and documenting the job site safety orientations for all new team members, subcontractors, and other appropriate vendors, visitors, etc.
- Establish emergency planning with project management, including identifying and arranging local emergency and healthcare services, identifying warning signals, evacuation assembly points, and escape routes
- Develop and set up systems to ensure proper handling of all Hazardous Material including proper use, storage, shipment, spill control and cleanup, and disposal
- Ensure compliance with all Safety or Environmental requirements per state and federal regulations
- Perform periodic industrial hygiene and environmental sampling
